Like his philosopher colleague, the Swiss thinker also believed that political philosophy should be a continuing dialogue with the classics. In the introduction to the Discourse sur lâ€™inégalité (The Origin of Inequality), Rousseau, almost echoing Machiavelli, set out to transcend history and speak directly to all of mankind. As my subject of interest is mankind in general, I shall endeavour to make use of a style adapted to all nations, or rather for The researcher affirms the notion that Jean-Jacques Rousseau's influence had a bearing in the origins and further development of participative management. Participative management is rooted on democratic ideals espoused by Rousseau in 1762 regardless of the fact that the concept of democracy can be traced from the present day to classical Athens in Greece in the 6 th century B.C. (Qvortrup, 2003). Social contract theory has its roots in part in the work of 18 th century political philosopher Jean-Jacque Rousseau [1], and more recently in the work of moral and political philosopher John Rawls, and his Theory of Justice [2]. Rousseau had by that time completed a second Discourse in response to a question set by the Academy of Dijon: "What is the origin of the inequality among men and is it justified by natural law?" In response to that challenge he produced a masterpiece of speculative anthropology. In the dedication Rousseau wrote for the second Discourse, in order to present it to the republic of Geneva, he nevertheless praised that city-state for having achieved the ideal balance between "the equality which nature established among men and the inequality which they have instituted among themselves."
